Professional Accreditations

EU Business School programs are accredited by the Accreditation Council for Business Schools and Programs (**ACBSP**) and the International Accreditation Council for Business Education (**IACBE**). Both of these accrediting bodies are recognized by the Council for Higher Education Accreditation (**CHEA**), one of the main US higher education agencies. Our institution has also earned the International Quality Accreditation (**IQA**) from the Central and East European Management Development Association (**CEEMAN**). Additionally, we have been certified by **eduQwa** in Switzerland.

To ensure that accreditations truly reflect an educational institution's status and academic standards, quality reports must be submitted annually and biennially to these accrediting bodies. The **University of Derby (UoD)** is a public university recognized by the U.K. government's higher education authorities. It is audited by the Quality Assurance Agency (QAA), the official quality assurance body for the Office of Students (OfS), the regulator for higher education in England. UoD was ranked 26th overall and in the top 10 for business, management, marketing and finance in the Guardian University Guide 2020.



The **University of Roehampton (UoR)** is a public university recognized by the U.K. government's higher educational authorities. It is audited by the Quality Assurance Agency (QAA), the official quality assurance body for the Office of Students (OfS), the regulator for higher education in England. UoR was ranked in the top 10 universities of London by the Times Good University Guide 2021, and was named Higher Education Institution of the Year 2020 by Aimhigher London Practitioner Awards.



The **Universidad Católica San Antonio de Murcia (UCAM)** is an officially recognized university in Spain. It is inscribed in the Registro Universitario de Centros y Títulos (Register of University Centers and Qualifications, RUCT) with the code 066, and is legally authorized to accredit higher education qualifications according to Organic Law 6/2001, 21st December, which pertains to universities. UCAM is accredited by La Agencia Nacional de Evaluación de la Calidad y Acreditación (ANECA). It is rated with four stars by QS Stars, and was ranked the 37th university in Spain in the Times Higher Education World University Rankings 2021.

EU Business School Programs

Bachelor's Degrees

Option 1: EU Bachelor's Programs

On successful completion of EU's six-semester, three-year bachelor's programs (BBA/BA/BS), students earn a degree from EU Business School Switzerland which is internationally accredited by ACBSP, IACBE, IQA and certified by EduQua, and a university bachelor's degree from Universidad Católica San Antonio de Murcia (UCAM), Spain, (*título propio*).

Option 2: EU Bachelor's + BA (Hons) in Business Management

Upon successful completion of EU's seven-semester, three-year bachelor's programs, students earn a degree from EU Business School Switzerland which is internationally accredited by ACBSP, IACBE, IQA and certified by EduQua, and a university bachelor's degree from Universidad Católica San Antonio de Murcia (UCAM), Spain, (*título propio*). In addition, they earn a state-accredited BA (Hons) in Business Management degree from the University of Derby, U.K.

Optionally, students may study an extra semester to earn a Diploma of Advanced Studies (DAS) in their specialization. The DAS is a diploma awarded by Universidad Católica San Antonio de Murcia (UCAM), Spain, (*título propio*).

Master's Degrees

EU Business School in Switzerland offers seven, three-term, one-year master's programs. With the completion of one of these programs, students earn a master's degree from EU Business School Switzerland which is internationally accredited by ACBSP, IACBE, IQA and certified by EduQua, as well as a university master's degree from Universidad Católica San Antonio de Murcia (UCAM), Spain, (*título propio*).

MBA Degrees

EU Business School in Switzerland offers eleven MBA programs. Upon successful completion of one of these programs, students earn an MBA degree from EU Business School Switzerland which is internationally accredited by ACBSP, IACBE, IQA and certified by EduQua, as well as a university MBA degree from Universidad Católica San Antonio de Murcia (UCAM), Spain, (*título propio*).

Dual Qualifications

While completing one of the EU MBA programs, students can also earn a state-accredited **MSc in International Management** or **MBA** degree from the University of Roehampton in London, U.K.

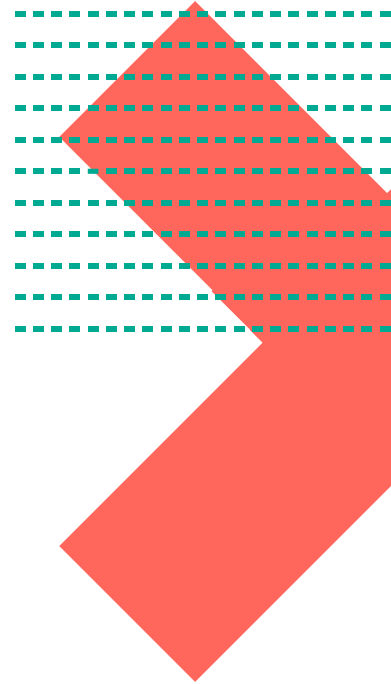

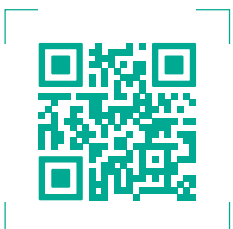
